

# **Important Notes about APPI Councillor Nominations:**

- To be eligible for nomination as a Councillor, the member must be a regulated member of the Institute either a Registered Professional Planner (RPP) or a Candidate member, in good standing. "In good standing" means the member has paid their 2025 member fees and is current with ongoing requirements of membership including but not limited to 2024 Continuous Professional Learning (CPL) reporting.
- 2. All Nominees must be Endorsed by two regulated members of the Institute in good standing.
- 3. Nomination forms must be submitted to the APPI Office by 12:00 PM on or before **February 27**, **2025**, and may be submitted by email to <a href="mailto:admin@albertaplanners.com">admin@albertaplanners.com</a> attention Nominating Committee.
